

Well written and interesting. It was written by two pharmacologists and a psychiatrist from Great Britain but is totally applicable to clinical practice here in the U.S.. Highly recommended.

I am a psychiatrist and this is a great reference. It provides pertinent information, has nice tables comparing medications and has pleasantly written text that is not at all boring to read. I find that this book goes where others don't go in terms of making dosing recommendations that don't just come

straight from the FDA recommended package inserts. It is a British text so some of the medications are not available in the US and a few US drugs aren't in this text but I still highly recommend it.
